RECIPROCAL AGREEMENT

{ G O L F } Usage will be allowed on a limited basis (five rounds per year) with tee times at the Golf Professional Staff's discretion. Peak play may be limited as the Golf Professional Staff sees fit. Reciprocal Club Members may call the host club directly. A \$30 golf cart charge will be assessed per person whether they take a cart or not. Tee times and range use will be in accordance with the home club's policy. Guests are welcome and will be charged standard guest fees and cart fees. Golf members are not allowed to play in other club's golf events. Non-Golf and Non-Resident members will not be extended reciprocal golf privileges. Each member must have their charges billed back to their club member account.

{ D I N I N G } Members may call the host club directly and have unlimited usage based on reservation availability with all charges billed back to their club member account.

{ P O O L } Usage will be on a limited basis with advance reservations required, and the usual guest fee will be charged back to the club member account.

{ C H A R G E S } Must be paid within three weeks of receipt of statements.
